1. DESCRIPTION

ADHERE Ci 1.0 is a cement-based construction tile adhesive formulated from hydraulic binders, limestone and siliceous aggregates and additives.

ADHERE Ci 1.0 is marketed in grey and white colours.

1. FIELD OF USE

ADHERE Ci 1.0 is especially suited for fixing small and medium-sized ceramic tiles, with high absorption on floors and interior walls, on cement-based substrates such as screed and renders.

4. APPLICATION

a) Substrate preparation

The substrates must be clean and free of dust, release oils, efflorescences and/or any other materials that may affect the adhesion. They must also be properly levelled, flattened and cohesive. Levelling can be checked using a 2m metal ruler.

On very absorbent substrates, they should be moistened before application. However, they should not be saturated with water at the time of application.

Always provide for placement and/or fractioning joints, so that they can absorb possible movements in the coating.

The ceramic coating must observe the structural joints existing in the substrate, such as expansion joints. These must be made watertight by applying a suitable sealant.

b) Preparation of mixture

ADHERE Ci 1.0 should be mixed with 4.0 to 4.5 litres of clean potable water for each 25 kg bag, with a low speed mixer, until a homogeneous and lump-free paste is obtained.

Allow the mixture to sit for 5 min and mix again.

c) Application

Spread the mixture on the substrate on small spreads, suitable for atmospheric temperature and humidity conditions. Level the surface obtained with a notched trowel suitable for the piece to be laid. The piece to be fixed must be pressed against the substrate with the aid of a rubber mallet, until the tile adhesive strands are completely crushed.

Do not proceed with the fixing when the open time is exceeded (see point 3.), which is confirmed by the presence of a film of different shade that appears on the surface of the tile adhesive.

The joints between indoor ceramics must be at least 2 mm apart.

d) Restrictions

ADHERE Ci 1.0 should never be applied in isolated portions, but rather covering the entire substrate to be coated with ceramic. The same applies to the back of the pieces to be bonded when double fixing is performed.

ADHERE Ci 1.0 should not be applied when the ambient temperature and/or the substrate is below 5°C or above 30°C. **ADHERE Ci 1.0** cannot be used for outdoor fixing.

a) Complementary Advices

- → No mortar that has started its open time should be applied.
- → Do not soften mortars by adding water after preparation;
- → Do not add any other products to the mortar. **ADHERE Ci 1.0** should be applied as it is shown in its original packaging.

Packaging

25 kg paper bags in plasticized pallets of 60 bags.

Validity

12 months provided the conditions of the original packaging remain unaltered and in good storage conditions, protected from extreme temperature and humidity.
