SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

By inhalation:

Remove the person affected from the area of exposure, provide with fresh air and keep at rest. 5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, handling and use.
