#### 1. DESCRIPTION

REDUR PK 02 is a synthetic stucco, produced with acrylic resins in aqueous dispersion, ready-to-use.

#### 2. FIELD OF USE

**REDUR PK 02** is a product intended to provide a smooth finish to indoor and outdoor walls and ceilings. It is used over hydraulic renders or in texture renovation operations over **REABILITA RS 34**, followed by painting.

REDUR PK 02 resists to the proliferation of fungi and contributes to the reduction of dirt accumulation.

#### 3. PRODUCT CHARACTERISTICS

#### 4. APPLICATION

### a) Substrate preparation

Substrates should be free from dust, release agents, loose or unstable materials, efflorescence, as well as any type of material that affects the normal conditions of adhesion.

The substrate must be levelled, completely dry and hardened. In case of new plasters, they should be levelled and trowelled with their cure completed.

In case the substrate needs levelling, the **REABILITA RS 34** regularization and renovation mortar should be used.

#### b) Application

Prior to application, the product should be homogenized in the bucket and mixed briefly.

**REDUR PK 02** should be spread in a very thin and uniform layer with a smooth metal trowel so as to fill all surface pores of the base. It should be applied in as many coats as needed for the intended finish.

The drying time per coat is 2 to 4 hours under normal conditions of temperature and humidity. Between layers, the surfaces should be properly sanded.

Before applying the finish with an aqueous base paint, let **REDUR PK 02** to dry at least 7 days.

#### c) Restrictions

**REDUR PK 02** should not be applied at room and substrate temperatures below 5 °C and above 30 °C and air relative humidity of more than 70 %.

Low temperatures and high relative humidity delay the drying of *REDUR PK 02*.

Application of *REDUR PK 02* should not be carried out when atmospheric conditions are adverse to the application and drying process such as:

- Frozen substrates;
- Substrates that are too hot;
- In case of rain or forecast of rain or showers, for 48 hours after application is completed;
- In the presence of strong, hot and dry wind; under direct, intense sun radiation. If possible, facades should be protected, so as to minimize the action of elements.

### d) Complementary Advices

Do not add any other products to the product. REDUR PK 02 should be applied as it is shown in its original packaging.

#### 5. PACKAGING AND VALIDITY

#### **Packaging**

7 kg and 25 kg buckets in plasticized pallets of 30 or 24 buckets, respectively.

#### Validity

12 months provided the conditions of the original packaging remain unaltered and in good storage conditions, protected from extreme temperature and humidity.
