Ready-mix concrete is a construction material consisting of a homogeneous mixture of cement, aggregates (coarse and fine), water, and optionally admixtures or additions. It is produced in a batching plant and delivered to the construction site in a fresh state, ready for placement.

This specific ready-mix concrete incorporates a hydrophobic admixture, providing water-repellent properties that enhance durability and reduce permeability.

The concrete is designed and manufactured in accordance with the requirements of NP EN 206 and complies with all relevant European standards for production control and testing.

Testing is carried out in accordance with EN 12350 and EN 12390.



Hydrophobic Ready-Mix Concrete is widely used in civil engineering, infrastructure works, and building construction, including but

not limited to:

Foundations (footings, raft slabs, cast-in-place piles)

Floor slabs and pavements (industrial, commercial, residential)

Structural elements (columns, beams, retaining walls)



# **Data quality**

The foreground data are based on extensive and detailed data collection at the production site of the manufacturer, covering key processes such as raw material sourcing, formulation, and manufacturing. These foreground data are fully linked with corresponding datasets from the background database (ecoinvent 3.10) or with EN15804+A2-compliant EPDs, ensuring consistency, reliability, and maintaining alignment with the latest industry standards.

The overall data representativeness is rated as good with an overall score of 3.94/5, in accordance with EN 15804+A2 Annex E guidance on data quality assessment, considering geographical, technical, and temporal representativeness.
